### **GeoCloud Privacy Policy**

GeoCloud Ltd. ("GeoCloud", or "us", "our", "we") provides a platform (the "Platform") that allows for third party software applications to be installed on the servers of GeoCloud (or its cloud service providers) and made available to third party end users on a metered "software-as-a-service" basis.

We respect the right to privacy of end users. Your ability to make informed choices about the use of your information is important to us. This privacy statement explains our policy regarding the collection, use, disclosure and protection of any information we receive.

#### **Information We Collect**

In order to use the Platform, you may be required to log in or register and provide specified information. If you create an account with us, we receive and store all information that you provide in the creation of the account.

GeoCloud collects data concerning the use of individual software applications by end users ("Application Data") which, for example, may contain for each end user: (a) name, (b) email address, (c) hours of use of application and (d) amounts paid by end user in respect of the use of the application. The Platform will also record certain information automatically, such as your IP address, mobile device or computer, operating system and browser. In addition, we collect any information you provide when you contact us for any reason. You are not required by law to provide us with any such information, but by using the Services and agreeing to the Terms you agree to provide us with such information.

We may use services such as Google Analytics or other analytics services that provides us with analysis of the use of our Services.

### **How We Use Information**

We will not share your Personal Information with third parties without your explicit permission, except when required by law, regulation, subpoena or court order or as otherwise expressly set forth herein. We may use Personal Information and other information internally – for example, to provide applicable support, to help diagnose problems with our servers, and to make the Platform more useful for you and for our other customers.

GeoCloud also uses Application Data to provide services (such as billing reports and services) to companies that make available software or services through the Platform.

By analyzing all information we receive, we may compile statistical information across a variety of users ("Statistical Information"). Statistical Information helps understand trends and customer needs so that new services can be considered and so the Services and associated services can be tailored to customer desires. We may share Statistical Information with our partners, pursuant to commercial terms that we determine in our sole discretion. In addition, we may provide any information to third parties, so long as we have removed any information that identifies any specific individual or user, such as a name, address or contact information.

# **How we Protect Information**

We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it. However, no method of transmission over the Internet, or method of electronic storage is 100% secure. Therefore, while we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

## Cookies

A cookie is a small piece of text that is sent to a visitor's browser. The browser provides this piece of text to the device of the originating visitor when this visitor returns. A "persistent" cookie may be used to help save your settings and customizations across visits. Most Web browsers are initially configured to accept cookies, but you can change this setting so your browser either refuses all cookies or informs you when a cookie is being sent. Also, you are free to delete any existing cookies at any time. Please note that some features of the Services may not function properly when cookies are disabled or removed.

**Third Party Services and Services** 

GeoCloud may use third parties to process information. For example, GeoCloud uses third parties to collect payment information, process billing information and transfer payments to GeoCloud and its partners. We are not responsible for the use of any data by third parties such as, for example, applications made available through the Platform, and we cannot vouch for the privacy policies of any third party. We have no control over thirdparty applications or services, and all use of third-party services is at your own risk. We cannot accept responsibility for the privacy policies of any such services. We are not responsible for content available by means of such services. We do not endorse any services or offered by third parties and we urge our users to exercise

caution in using third-party Services or services.

Children

We do not knowingly collect Personal Information from children under the age of 14. In the event you become aware that an individual under the age of 14 has enrolled without parental permission, please advise us

immediately.

Other Uses or Transfer of Your Information

We will fully cooperate with any law enforcement authorities or court order requesting or directing us to disclose

the identity or behavior of any user suspected to have engaged in illegal behavior.

We may use subcontractors that are located in countries other than your own, and send them information we receive. For example, we may send your information to any countries outside the United States, Canada or the European Union. All our subcontractors will be subject to non-disclosure and non-use obligations. Nevertheless, some countries may have levels of protection of personal and other information which are not as high as in your

country of residence or business.

GeoCloud may disclose data as necessary for it to enforce its agreements and policies, to investigate any claims

against GeoCloud, and to protect the rights and property of GeoCloud or its agents, employees and customers.

We may transfer our databases containing information if we sell our business or part of it, or in the event of an insolvency, bankruptcy, or receivership in which information is transferred to one or more third parties as one

of GeoCloud's business assets.
